

REGULATION OF THE MINISTER OF RESEARCH, TECHNOLOGY AND HIGHER
EDUCATION OF THE REPUBLIC OF INDONESIA

NUMBER 62 OF 2016

CONCERNING

HIGHER EDUCATION QUALITY ASSURANCE SYSTEM

MINISTER OF RESEARCH, TECHNOLOGY AND HIGHER EDUCATION OF
THE REPUBLIC OF INDONESIA,

Considering : that in order to implement the provisions of Article 52 paragraph (3) and Article 54 paragraph (8) of Law Number 12 of 2012 concerning Higher Education, it is necessary to stipulate a Regulation Minister of Research, Technology and Higher Education concerning Higher Education Quality Assurance System;

In view of : 1. Law Number 12 of 2012 concerning Higher Education (State Gazette of the Republic of Indonesia Year 2012 Number 158, Supplement to the State Gazette of the Republic of Indonesia Number 5336);

2. Government Regulation Number 4 of 2014 concerning Implementation of Higher Education and Management of Higher Education (State Gazette of the Republic of Indonesia of 2014 Number 16, Supplement to State Gazette of the Republic of Indonesia Number 5500);

3. Presidential Regulation Number 13 of 2015 concerning Ministry of Research, Technology and Higher Education (State Gazette of the Republic of Indonesia of 2015 Number 14);

4. Presidential Decree Number 121/P of 2014 concerning Formation of Ministries and Appointment of Kabinet Kerja Ministers for the 2014-2019 Period;

5. Regulation of the Minister of Research, Technology and Higher Education Number 15 of 2015 concerning the Organization and Work Procedure of the Ministry of Research, Technology and Higher Education (State Gazette of the Republic of Indonesia of 2015 Number 889);

6. Regulation of the Minister of Research, Technology and Higher Education Number 44 of 2015 concerning National Standards for Higher Education (State Gazette of the Republic of Indonesia of 2015 Number 1952);

HAS DECIDED:

To Stipulate : REGULATION OF THE MINISTER OF RESEARCH, TECHNOLOGY AND HIGHER EDUCATION CONCERNING HIGHER EDUCATION QUALITY ASSURANCE SYSTEM.

CHAPTER I GENERAL PROVISIONS

Article 1

In this Ministerial Regulation what is meant by:

1. Quality of Higher Education is the level of conformity between the implementation of higher education and Higher Education Standards which consist of the National Higher Education Standards and Higher Education Standards stipulated by Tertiary Education Institutions.
2. Higher Education Quality Assurance System, hereinafter abbreviated as SPM Dikti, is a systemic activity to improve the quality of higher education in a planned and sustainable manner.
3. Internal Quality Assurance System, hereinafter abbreviated as SPMI, is a systemic activity of higher education quality assurance by each tertiary institution autonomously to control and improve the implementation of higher education in a planned and sustainable manner.
4. External Quality Assurance System, hereinafter abbreviated as SPME, is an assessment activity through accreditation to determine the eligibility and level of achievement of the quality of study programs and tertiary institutions.
5. Higher Education Database, hereinafter abbreviated as PD Dikti, is a nationally integrated collection of data on the implementation of higher education for all tertiary institutions.
6. National Standards for Higher Education are standard units which include National Education Standards plus National Research Standards and Community Service National Standards.
7. Higher Education Standards set by Tertiary Education Institutions are a number of standards in tertiary institutions that exceed the National Higher Education Standards.
8. Higher Education is an educational unit that organizes higher education.
9. Higher Education National Accreditation Board, hereinafter abbreviated as BAN-PT, is an agency established by the Government to carry out and develop higher education accreditation independently.

10. Study program Independent Accreditation Institution, hereinafter abbreviated as LAM, is an institution established by the Government or the community to carry out and develop study program accreditation independently.
11. Ministry is a government apparatus in charge of government affairs in higher education.
12. Minister is the minister administering government affairs in higher education.
13. Directorate General is the Directorate General of Learning and Student Affairs, Ministry of Research, Technology and Higher Education.
14. Directorate is the Directorate of Quality Assurance, Directorate General of Learning and Student Affairs, Ministry of Research, Technology, and Higher Education.

Article 2

- (1) SPM Dikti aims to guarantee the fulfillment of Higher Education Standards in a systemic and sustainable manner, so that a culture of quality grows and develops.
- (2) Higher Education's SPM has the function of controlling the implementation of higher education by tertiary institutions to create quality higher education.

CHAPTER II HIGHER EDUCATION QUALITY ASSURANCE SYSTEM MECHANISM

Article 3

- (1) Higher Education SPM consists of:
 - a. SPMI; and
 - b. SPME
- (2) SPMI as referred to in paragraph (1) letter a is planned, implemented, evaluated, controlled and developed by tertiary institutions.
- (3) SPME as referred to in paragraph (1) letter b is planned, evaluated, implemented, controlled, and developed by BAN-PT and/or LAM through accreditation in accordance with their respective authorities.
- (4) The results of the implementation of SPMI by tertiary institutions as referred to in paragraph (2) are used by BAN-PT or LAM to determine the accredited status and ranking of tertiary institutions or study programs.

Article 4

- (1) Planning, implementation, evaluation, control, and development of SPMI and SPME are based on Higher Education Standards.

- (2) Higher Education Standards as referred to in paragraph (1) consist of:
 - a. Higher Education National Standards; and
 - b. Higher Education Standards Set by College.
- (3) National Higher Education Standards are prepared and developed by the Higher Education National Standards Agency and stipulated in a Ministerial Regulation.
- (4) Higher Education Standards Set by Tertiary Education Institutions are compiled and developed by tertiary institutions and stipulated in the regulations of higher education leaders for PTNs, or regulations of implementing legal entities for PTS, after being approved by the senate at the tertiary level.

Article 5

- (1) SPMI has an activity cycle consisting of:
 - a. stipulation of Higher Education Standards;
 - b. implementation of Higher Education Standards;
 - c. evaluation of the implementation of Higher Education Standards
 - d. controlling the implementation of Higher Education Standards; and
 - e. improvement of Higher Education Standards.
- (2) The evaluation referred to in paragraph (1) letter c is carried out through an internal quality audit.
- (3) SPMI is implemented in all fields of higher education activities, namely the fields of:
 - a. academic, including education, research, and community service; and
 - b. non-academic, including human resources, finance, facilities and infrastructure.
- (4) The activities referred to in paragraph (3) are used to achieve Higher Education Standards.
- (5) SPMI as a system is continuously evaluated and developed by the tertiary institution concerned.
- (6) SPMI is stipulated in the higher education leadership regulations for PTN or the implementing legal entity regulations for PTS, after being approved by the senate or tertiary academic senate.

Article 6

- (1) SPME which is carried out through accreditation has an activity cycle consisting of:
 - a. Data and Information Evaluation stage;

- b. stage of Determination of Accreditation Status and Rating Accredited; and
 - c. stage of Monitoring and Evaluation of Accreditation Status and Accredited Rating.
- (2) SPME is developed on an ongoing basis by BAN-PT and/or LAM in accordance with their respective authorities.
- (3) Further provisions regarding the activity cycle as referred to in paragraph (1) are regulated in a Ministerial Regulation.

Article 7

Data, implementation information, and outputs of SPMI and SPME are reported and stored by universities in PD Dikti.

CHAPTER III DISTRIBUTION OF DUTIES AND AUTHORITIES

Article 8

- (1) The Directorate General has duties and authorities in the formulation, coordination and implementation of the Higher Education SPM policies.
- (2) The Higher Education National Standards Agency has the task and authority to compile and develop the Higher Education National Standards.
- (3) The Directorate has duties and authorities in preparing the formulation of policies, facilitation, implementation, coordination, supervision, monitoring control, evaluation and reporting in the field of SPMI.
- (4) Higher Education has duties and authorities:
- a. plan, implement, evaluate, control, and develop SPMI;
 - b. prepare SPMI documents consisting of:
 - 1. SPMI policy document;
 - 2. SPMI manual documents;
 - 3. standard document in SPMI; And
 - 4. document forms used in SPMI;
 - c. establish a quality assurance unit or integrate SPMI into higher education management; and
 - d. managing PD Dikti at the tertiary level.

- (5) The National Accreditation Board for Higher Education (BAN PT) and/or the Independent Accreditation Institute (LAM) has the duty and authority to carry out SPME through the accreditation of Higher Education and/or study programs.

CHAPTER IV TRANSITIONAL PROVISIONS

Article 9

Before the Higher Education National Standards Agency as referred to in Article 8 paragraph (2) was formed, the duties and powers of the Higher Education National Standards Agency were carried out by the Directorate General.

CHAPTER V CLOSING PROVISIONS

Article 10

When this Ministerial Regulation comes into effect, the Regulation of the Minister of Education and Culture Number 50 of 2014 concerning the Higher Education Quality Assurance System (State Gazette of the Republic of Indonesia of 204 Number 788), is revoked and declared no longer valid.

Article 11

This Ministerial Regulation shall come into force on the date of promulgation.

In order that everyone knows about it, ordered the promulgation of this Ministerial Regulation by placing it in the State Gazette of the Republic of Indonesia.
