# NEW STUDENTS' ADMISSION FOR DIPLOMA PROGRAM AND GRADUATE PROGRAM AT STATE HIGHER EDUCATION

## BY THE GRACE OF GOD ALMIGHTY

## MINISTER OF EDUCATION, CULTURE, RESEARCH, AND TECHNOLOGY OF THE REPUBLIC OF INDONESIA.

## Considering

- : a. that the direction of the higher education transformation policy aims to form graduates who have multidisciplinary competence and have a strong foundation in the main disciplines of each study program;
  - b. that the direction of higher education transformation policy implemented in the acceptance mechanism of new students at state universities nationally and independently who are in line with the spirit of independent learning to encourage improvement and improvement of the quality of education at the previous level;
  - c. that Regulation of the Minister of Education and Culture Number 6 of 2020 concerning Acceptance of New Students for Undergraduate Programs at State Universities does not yet meet the needs of the current admissions system for state universities, so it needs to be replaced;
  - d. that based on the considerations referred to in letters a, b, and c, it is necessary to stipulate a Regulation of the Minister of Education, Culture, Research, and Technology concerning Admission of New Students for Diploma Programs and Undergraduate Programs at State Universities;

To Stipulate : REGULATION OF THE MINISTER OF EDUCATION, CULTURE, RESEARCH, AND TECHNOLOGY OF THE REPUBLIC OF INDONESIA CONCERNING NEW

## STUDENTS' ADMISSION FOR DIPLOMA PROGRAM AND GRADUATE PROGRAM AT STATE HIGHER EDUCATION

## CHAPTER I GENERAL PROVISIONS

## Article 1

## Referred to herein as:

- 1. The State University, hereinafter abbreviated as PTN is a tertiary institution established and/or organized by the Government.
- 2. The Diploma Program is vocational education intended for graduates of secondary education or its equivalent to develop skills and reasoning in the application of Science and/or Technology.
- 3. Undergraduate Program is an academic education intended for graduates of secondary education or equivalent so that they are able to practice science and technology through scientific reasoning.
- 4. Study Program is a unit of educational activities and learning that has a certain curriculum and learning methods in one type of academic education, professional education, and/or vocational education.
- 5. Capacity is the capacity of the Study Program for accommodating the number of students in the education process based on the availability of human resources, learning infrastructure, and/or laboratories at PTN in accordance with statutory provisions.
- 6. Ministry is the ministry that organizes the government affairs in the field of education.
- 7. Minister is the minister who organizes government affairs in the field of education.
- 8. Students are students at the higher education level.

## **CHAPTER II**

PRINCIPLES, SCOPE, AND PATHWAYS FOR NEW STUDENTS' ADMISSION

## Article 2

Admission of new students at PTN is held with the following principles:

- a. fair, namely giving open opportunities without differentiating ethnicity, religion, race, and inter-group, with affirmation for groups of people who are economically disadvantaged;
- b. accountable, that is carried out in accordance with procedures and clear criteria;
- c. flexible, namely providing flexibility for prospective students to choose the selection path, Study Program, and the intended PTN;
- d. efficient, namely the administration of PTN entrance tests using resources optimally;
- e. transparent, namely the implementation of the acceptance of new PTN students is carried out openly and the implementation results are easily accessible; And
- f. the prohibition of conflicts of interest, namely the implementation of new PTN student admissions is carried out while still paying attention to the results of academic selection and avoiding corruption, collusion, and nepotism.

The scope of acceptance of new students for the Diploma Program and Undergraduate Program at PTN consists of the following programs:

- a. diploma three;
- b. diploma four or applied bachelor; and
- c. bachelor.

### Article 4

Acceptance of new students as referred to in Article 3 is carried out through the following channels:

- a. national selection based on merit;
- b. national selection based on tests; and
- c. independent selection by PTN.

## Article 5

- (1) National selection based on achievement as referred to in Article 4 letter a includes academic and/or non-academic achievements.
- (2) The national selection is based on merit as referred to in paragraph (1) is carried out based on 2 (two) components namely:
  - a. the first component, which is calculated based on the average value of the report cards of all subjects at least 50% (fifty percent) of the rating weight; And

- b. the second component, which is calculated based on the value of the report card at most 2 (two) supporting subjects of the intended Study Program, portfolio, and/or achievement of at most 50% (fifty percent) of the assessment weight.
- (3) The composition of the percentage of the first component and the second component as referred to in paragraph (2) is determined by each PTN with a total of 100% (one hundred percent).
- (4) Study Program supporting subjects as referred to in paragraph (2) letter b is determined by the Minister. (5) The achievements referred to in paragraph (2) letter b determined by each PTN.
- (5) The portfolio referred to in paragraph (2) letter b is devoted to the Arts Study Program and the Sports Study Program and is determined by each PTN.
- (6) PTN may add requirements other than the components referred to in paragraph (2) for certain Study Programs that require specific skills.
- (7) Additional requirements as referred to in paragraph submitted by PTN to the Ministry.

- (1) The national selection based on the test as referred to in Article 4 letter b is carried out using a computer-based standardized test.
- (2) The standardized test referred to in paragraph (1) is a test that measures cognitive potential, mathematical reasoning, literacy in Indonesian and literacy in English.
- (3) National selection based on the test referred to in paragraph (1) can be held several times in the current year and each prospective student can take a maximum of 2 (two) times the national selection based on tests.

## Article 7

- (1) In carrying out the national selection based on the tests referred to in Article 6, PTN can add portfolio requirements for the arts study program and sports study program.
- (2) PTN can add requirements other than portfolio as referred to in paragraph (1) for certain Study Programs that require specific skills.
- (1) Additional requirements as referred to in paragraph submitted by PTN to the Ministry.

## Article 8

(1) Selection independently by PTN as referred to in Article 4 letter c is carried out based on academic selection and is prohibited from being associated with commercial purposes.

- (2) Prior to carrying out the independent selection by PTN as referred to in paragraph (1), PTN shall announce the selection procedure to the public which at least contains the following matters:
  - a. the number of prospective students who will be accepted each Study Program/faculty;
  - b. Student prospective assessment methods, consisting of:
    - 1. test independently;
    - 2. test cooperation through a consortium of universities;
    - 3. utilize the scores from the results of the national selection based on tests; and/or
    - 4. other required student candidate assessment methods.
  - c. the amount of fees or the method of determining the amount of fees charged to prospective students who pass the selection; And
  - d. prospective students or the public can report through the reporting channel of the Inspectorate General of the Ministry's whistleblowing system if they have initial evidence of violations of regulations in the selection process.
- (3) After the implementation of independent selection by PTN as referred to in paragraph (1), PTN shall announce to the public at least the following matters:
  - a. the number of selection participants who passed the selection and the rest unfilled quota;
  - b. objection period of 5 (five) working days after the announcement of the selection results;
  - c. procedures for objecting the selection results; And
  - d. Prospective students or members of the public can report through the Ministry Inspectorate General's whistleblowing system reporting channel if they have initial evidence of violations of regulations in the selection process.
- (4) Announcement as referred to in paragraph (2) and paragraph (3) is carried out in each selection wave independently by PTN.
- (5) Details of procedures for independent selection by state universities determined by each Head of PTN.

## CHAPTER III

IMPLEMENTATION AND ANNOUNCEMENT OF NEW STUDENTS' ADMISSION

Admission of new students at PTN as referred to in Article 4 is held by utilizing information technology.

## Article 10

- (1) The implementation and announcement of the results of the national selection based on merit is carried out prior to the implementation of the national selection based on tests.
- (2) Implementation of national selection based on merit as referred to in paragraph (1) starting from the registration process to the implementation of the achievement selection.

## Article 11

- (1) National selection based on tests can be carried out in the final semester of the current academic year prior to the announcement of secondary education graduation until after the announcement of secondary education graduation in the current academic year.
- (2) The implementation of the national selection based on the test as referred to in paragraph (1) starts from the registration process to the implementation of the test.
- (3) Announcement of the results of the national selection based on tests carried out after the announcement of high school graduation.

## Article 12

- (1) Implementation of independent selection by PTN is carried out after the announcement of the results of the national selection based on tests.
- (2) Announcement of selection results independently by PTN as referred to in paragraph (1) shall be carried out no later than the end of July of the current year.
- (3) In the event that after the announcement of the results of the independent selection by the PTN as referred to in paragraph (2), the number of prospective students who have passed the selection in the PTN Study Program has not reached 50% (fifty percent) of the total Capacity of the Study Program, the PTN may extend the wave of independent selection in the Study Program until August 15 of the current year.

## Article 13

The period for the implementation date and announcement of national selection based on achievement and national selection based on tests is determined by the Ministry.

- (1) The criteria and determination of the passing results of national selection based on merit, national selection based on tests, and independent selection by PTNs is the authority of PTN Leaders.
- (1) PTN leaders are required to provide data on prospective students and the results of selection to enter PTN from each route to Minister.

## CHAPTER IV

## CAPACITY ADMISSION OF NEW STUDENTS

## Article 15

## (1) PTN determines and announces the number of new students' capacity for:

- a. national selection based on merit;
- b. national selection based on tests; and
- c. independent selection by PTN.
- (2) The capacity of National Selection Students based on achievement as referred to in paragraph (1) letter a for each Study Program at PTN is determined to be at least 20% (twenty percent).
- (3) The National Selection Student Capacity based on the test referred to in paragraph (1) letter b for each Study Program at PTN other than legal entity PTN is determined to be at least 40% (forty percent).
- (4) The National Selection Student Capacity based on the test referred to in paragraph (1) letter b for each Study Program at PTN legal entities is set at least 30% (thirty percent).
- (5) The capacity for independent selection by PTN as referred to in paragraph (1) letter c for each Study Program at PTN other than legal entity PTN is set at a maximum of 30% (thirty percent).
- (6) The capacity for independent selection by PTN as referred to in paragraph (1) letter c for PTN legal entities is set at a maximum of 50% (fifty percent) of the capacity of each Study Program.

## Article 16

(1) The capacity of each Study Program as referred to in Article 15, is determined by the Decree of the Head of PTN.

- (2) In the event that the capacity for national selection based on merit as referred to in Article 15 paragraph (2) is not met, the capacity for national selection based on merit can be transferred to the national selection based on tests.
- (3) In the event that the capacity for national selection based on tests as referred to in Article 15 paragraph (3) and paragraph (4) is not met, the capacity for national selection based on tests can be transferred to selection independently by state universities.
- (4) Changes in capacity as referred to in paragraph (2) and paragraph (3) are stipulated by decision of the head of the PTN and announced prior to the implementation of the national selection based on tests and independent selection by the PTN.

PTNs are required to provide access for prospective students with disabilities to take part in national selection based on merit, national selection based on tests, and independent selection by PTN according to the needs of prospective students' various disabilities.

## Article 18

PTN reports the capacity, changes in capacity, and the results of the selection of new student admissions, national selection based on achievement, national selection based on tests, and independent selection by PTN no later than 30 (thirty) days after the end of the implementation of new student registration to the Minister.

## Article 19

- (1) PTN is required to seek and recruit prospective students who have high academic potential, but are economically disadvantaged and/or prospective students from frontier, outermost, and disadvantaged areas to be accepted by at least 20% (twenty percent) of all new students who accepted and spread in all Study Programs.
- (2) PTN in capturing prospective students as referred to in paragraph (1) is carried out through national selection based on merit, national selection based on tests, and independent selection by state universities.

## **CHAPTER V**

## NATIONAL SELECTION ORGANIZERS

### Article 20

National selection based on achievement and national selection based on tests are organized by the Ministry in collaboration with PTN.

## **CHAPTER VI**

## REQUIREMENTS FOR SELECTION PARTICIPANTS AND PROSPECTIVE STUDENTS

### Article 21

- (1) Requirements for national selection participants based on merit are as follows:
  - a. final year students in secondary education who will graduate in the current year;
  - b. have good and consistent academic and/or non-academic achievements;
  - c. enter the best ranking quota in schools determined based on school accreditation; and
  - d. meet other requirements specified by each PTN.
- (2) The criteria for having good and consistent academic and/or non-academic achievements as referred to in paragraph (1) letter b and entering the best ranking quota in the school as referred to in paragraph (1) letter c shall be determined by the Ministry.
- (3) Determination of selected student candidates through national selection based on achievement is carried out by each PTN.

## Article 22

The requirements for national selection participants are based on the following tests:

- a. final year students in secondary education who will graduate in the current year; or
- b. graduates of secondary education no later than 3 (three) years.

## Article 23

The requirements for independent selection participants by the PTN are determined by the Head of the PTN and reported to the Ministry.

## Article 24

Requirements to be accepted as a new PTN student as follows:

- a. follow and declared pass the acceptance selection
- a. New students:
- b. already has an original diploma or certificate of graduation in secondary education; and
- c. meet the requirements set by PTN.

Prospective students who have passed the selection process and have registered are designated as new students through the decision of the Head of PTN

# CHAPTER VII FUNDING AND FINANCIAL ACCOUNTABILITY

## Article 26

- (1) Funding for the implementation of national selection based on merit is the responsibility of the Ministry.
- (2) Funding for national selection based on tests is the responsibility of the Ministry and participants.
- (3) Funding for the implementation of independent selection by PTN charged to the participants.

## Article 27

Management and financial accountability for the implementation of the national selection path based on merit, national selection based on tests, and independent selection by state universities are carried out in accordance with statutory provisions.

## CHAPTER VIII GUIDANCE AND SUPERVISION

## Article 28

- (1) The Minister shall provide guidance and supervision to PTNs in fulfilling norms, standards, procedures and criteria at all stages of selection for new student admissions.
- (2) The Minister can cancel PTN decisions regarding results selection of new student admissions in the event that after an inspection by the Inspectorate General of the Ministry on the Minister's instructions it is proven that the decision violates the provisions of the laws and regulations.

# CHAPTER IX MISCELLANEOUS PROVISIONS

In the event that the national selection based on the test referred to in Article 6 paragraph (1) cannot be carried out due to disability, nature and/or infrastructure problems, the test can be carried out in writing in printed form and/or with assistance.

# CHAPTER X CLOSING PROVISIONS

### Article 30

When this Ministerial Regulation comes into force:

- a. all assets arising from the implementation of the duties and functions of the higher education entrance test institute as stipulated in the Regulation of the Minister of Education and Culture Number 6 of 2020 concerning Acceptance of New Students for Undergraduate Programs at State Universities (State Gazette of the Republic of Indonesia of 2020 Number 50) are recorded as assets of the Ministry; and
- b. Regulation of the Minister of Education and Culture Number 6 of 2020 concerning Admission of New Undergraduate Students at State Universities (State Gazette of the Republic of Indonesia of 2020 Number 50), revoked and declared no longer valid.

## Article 31

This Ministerial Regulation shall come into force on the date of promulgation so that everyone knows about it, ordered the promulgation of this Ministerial Regulation by placing it in the State Gazette of the Republic of Indonesia.
